# About BRISMES

Founded in 1973, BRISMES provides a forum for educators and researchers in Middle East Studies. Membership is open to all regardless of nationality or country of residence. We currently have around 500 members drawn from all over the world and are governed by a Council of trustees elected from the membership. We work to promote interest in Middle East Studies and to raise awareness of the region and how it is connected to other parts of the world, including the UK. Middle Eastern Studies is a diverse field, which encompasses all the humanities and social sciences and reaches from the present back to classical antiquity.

The long history of our field of study has made us particularly aware of the relationship between knowledge and power. We see connections between research, education, teaching and fundamental questions of social change. We do not believe that research and education should be divorced from the wider social and political context nor that it should exist to serve elites. We believe that a commitment to promote research and education in Middle Eastern Studies involves a duty to consider the conditions under which knowledge is produced and disseminated, and if necessary, to speak out against power structures and interests that prevent the flourishing of research and education in our field.

## **Website and Resources**

We are continuing to develop and expand our website including the Database of Expertise which includes the details of over 600 MENA experts and collaborative research projects. Our aim is to offer a one-stop shop for access to other sites of interest, information on vacancies, calls for papers and other opportunities.

## **The British Journal of Middle Eastern Studies (BJMES)**

Established in 1974 as the BRISMES Bulletin, BJMES assumed its present title in 1991 reflecting its growth into a fully-fledged scholarly journal. The journal, which is free to members, is published five times a year through Taylor & Francis and is currently under the editorship of Dr Lloyd Ridgeon (University of Glasgow).

## **Awards**

We offer a number of funding opportunities and prizes to support and recognize outstanding research and contributions to the field of Middle East Studies. The BRISMES Award for Services to Middle Eastern Studies is an honorary award presented annually in recognition of outstanding services to Middle Eastern Studies.

As part of our ongoing commitment to supporting students and Early Career Researchers, in 2021 we established the BRISMES Conference Student Paper Prize and the BRISMES Early Career Development Prize. BRISMES also administers the Leigh Douglas Memorial Prize which is awarded annually to the writer of the best PhD dissertation on a Middle Eastern topic in the Social Sciences and Humanities awarded by a British university in the previous calendar year.

## **Events**

We organise regular events including an annual public lecture from a distinguished scholar or expert within the field of Middle Eastern Studies and events for students and early-career researchers organised by our Graduate Section. We also organise the BRISMES Annual Conference, the largest and most prestigious annual UK gathering of scholars and practitioners focussed on the region. The online BRISMES events calendar lists external MENA-related events taking place in the UK and online.

## **Graduate Section**

The BRISMES Graduate Section is a hub for students and early career researchers to have an active voice in the organisation. The BRISMES Graduate Section provides support and advice to current and prospective graduate students; hosts events and workshops; raises awareness of academic resources, funding opportunities and career opportunities; and plays a vital role in making BRISMES more representative and better equipped to promote Middle Eastern studies.

## **Committee on Academic Freedom**

The BRISMES Committee on Academic Freedom was set up to monitor and defend academic freedom in the research, study and teaching of Middle East Studies in the UK and anywhere in the world, including academic institutions in the Middle East and North Africa. The Committee does this by monitoring issues of academic freedom relating to the Middle East and North Africa and to the study of those regions and by defending academic freedom through communications on behalf of the Society.

## Obituary | BRISMES President Haleh Afshar, 1944-2022

The Trustees of the British Society for Middle Eastern Studies are deeply saddened by the passing of our friend and President, Haleh Afshar, on May 12 after a long struggle with cancer. She is survived by her husband, Maurice Dodson, and their son and daughter.

Born in Iran in 1944, she was educated partly in the UK and after rejecting a place at Girton College, Cambridge, studied social science at York, and eventually a PhD in Land Economy at Cambridge. In Iran, she took up a place at the Ministry of Co-Operatives and Rural Development before the revolution. There, she worked to inform women of their rights and to help them claim these. Haleh Afshar was eventually forced to leave Iran for exile in 1974.

Haleh was active in several professional associations. In addition to BRISMES, she convened the Women's Groups of the Political Studies Association, and convened the Women's Studies and Development Studies Groups of the Development Studies Association.

As an academic, Haleh published extensively on Iran and on questions of race and gender, and singly or jointly edited several volumes including *Islam and Feminism* (1998), *Women and Empowerment* (1998), *Women and Politics in the Third World* (1996), *Women and Adjustment Policies in the Third World* (1992), *Women, the State and Ideology* (1987), and *Iran: A Revolution in Turmoil* (1985). With Mary Maynard, she was series editor of the University of York's Women's Studies Book Series.

While the topicality of these issues, sadly, has not diminished over her career, she remained active not just as a scholar but also in working directly to counter racism and misogyny, as well as on issues related to Iranian and Middle Eastern politics more broadly.

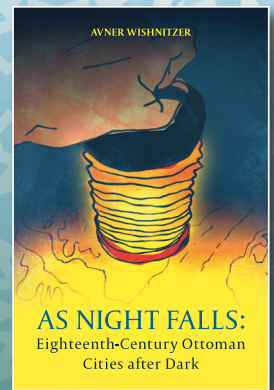
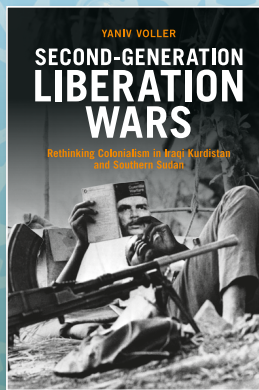
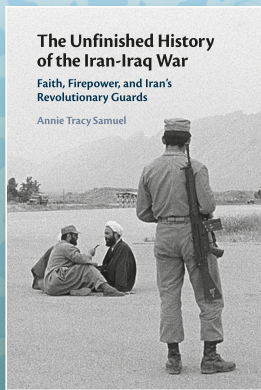
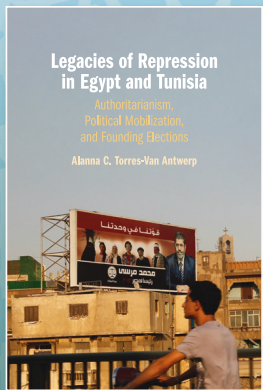
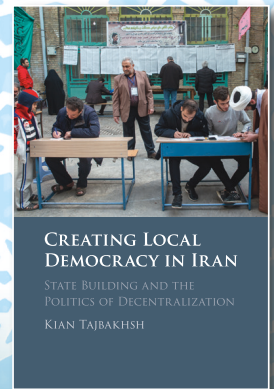
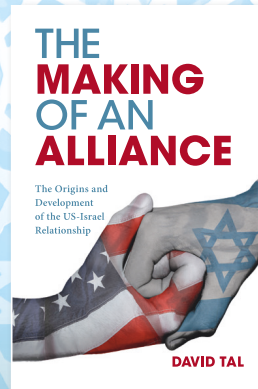
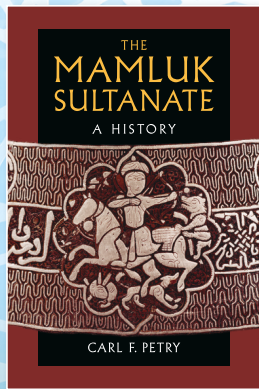
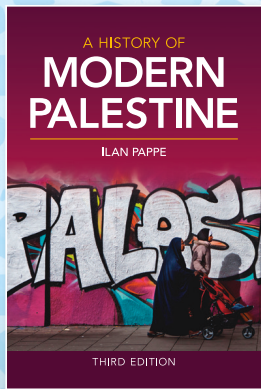
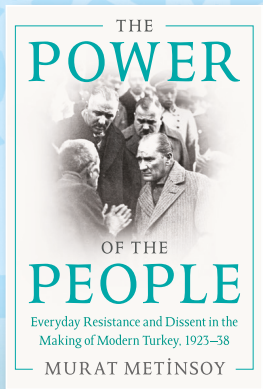
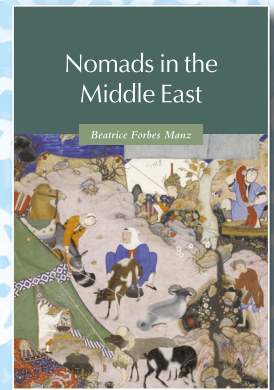
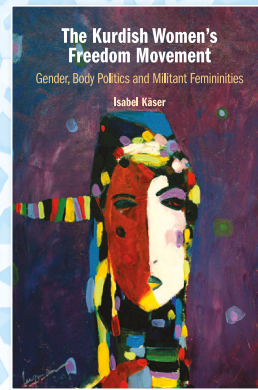
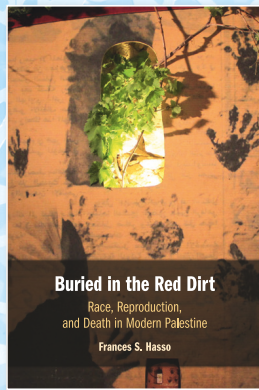
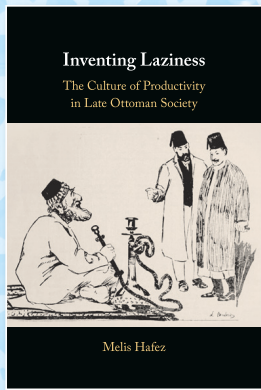
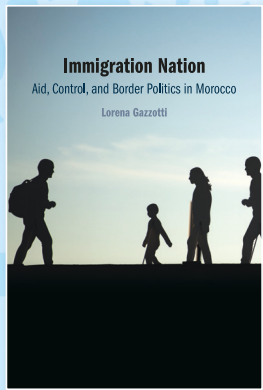
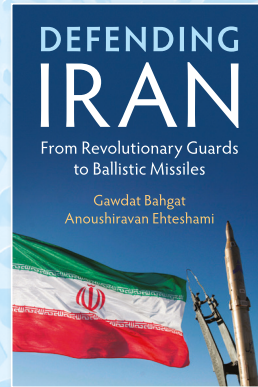
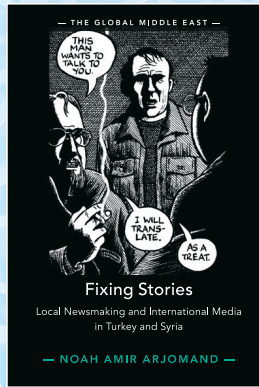
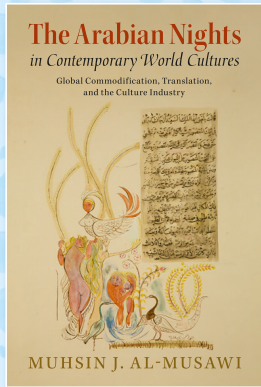
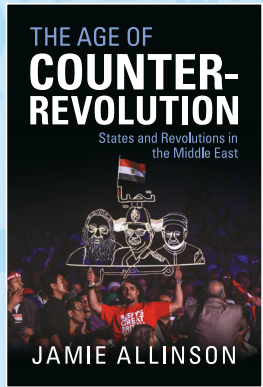
Following her work on the Women's National Commission, she was appointed OBE in 2005 and made Baroness Afshar in 2009 in the first slate of 'people's Peers'.

# The Conference

## **Exploring and Contesting the (Re)production of Coloniality in the Middle East: Borders, Transnationalism, and Resistance**

From the Napoleonic invasions to the European mandate system; from the Crusades to the current occupation of Palestine; from the founding of ARAMCO to the Iraq War, colonialism has had a deep and lasting impact on the political, economic, and social fabric of the Middle East. Even the modern demarcation of a 'Middle East' region has been shaped by colonial practice and knowledge production. But just as colonialism in the region has a long history, so too does decolonisation, expressed through social movements, states, institutions, intellectuals, and acts of everyday resistance and reimagination. With the global and historic calls for decolonisation, reparations, and justice increasingly being made and heard within the academy, this conference seeks to amplify and deepen the conversation on (de) coloniality within Middle East studies. We especially invite theoretical and empirical engagements on:

1. The historical role that colonialism and racism played in both producing and disrupting networks, geographies, imagined communities, trade, lingua-francas, and transnational/ transborder solidarities, identities, and ideologies in the Middle East (and beyond);
2. The role that borders and transnationalism play in shaping politics and society in the region today, brought into sharp focus via increased migrant and refugee movements; occupation; statelessness; transnational solidarities for justice; and the cross-border spread of authoritarian/ sectarian/ and racial repression;
3. Continuities of pre-colonial identities, communities, networks, and practices, that have remained resilient both within the region, and between the region and other parts of the world, despite the impact of colonialism and capitalism.
4. And finally, the conference seeks to build on the theme of the 2021 BRISMES conference: How does knowledge production uphold or contest coloniality in Middle East studies? How has contemporary scholarship evolved and changed to recognise the impact colonialism has had on the way the Middle East was/is studied, taught, and perceived, both within and outside of the Middle East region? To what extent have non-hegemonic narratives, methods, and theories, been afforded greater prominence in Middle East studies? How truly global is the knowledge exchange in Middle East studies, or will a resurgence of nationalism and restrictions on scholarly mobility have a lasting impact on the nature of knowledge production in Middle East studies?

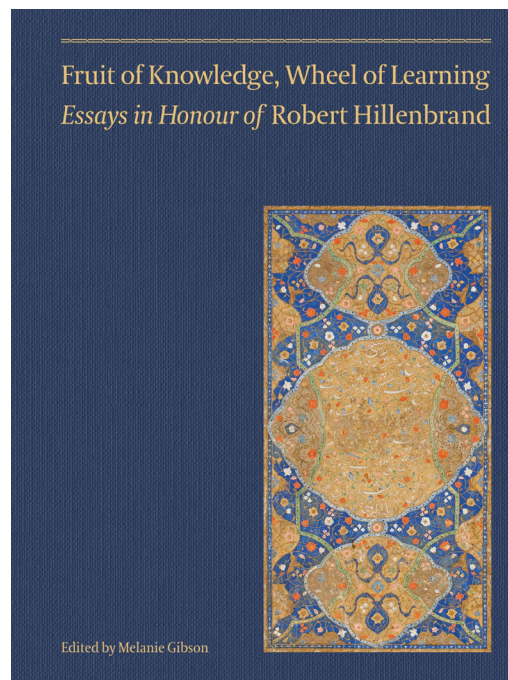
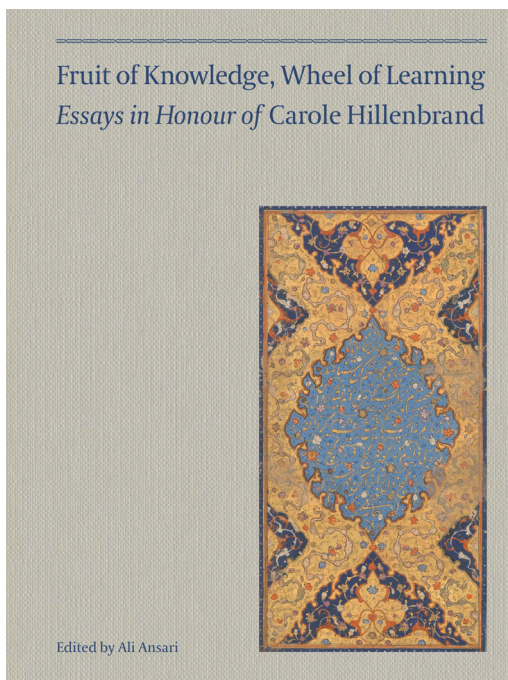

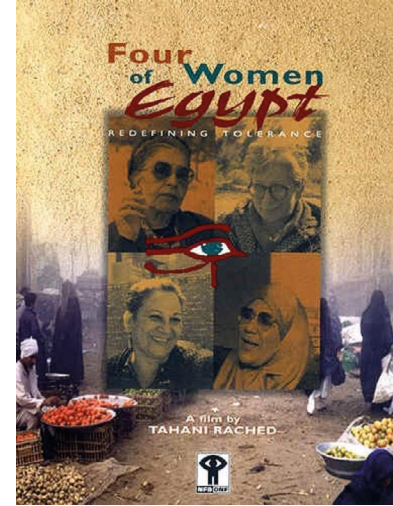




**Four Women of Egypt, Film screening with Q&A and Discussion  
School 3 - Wednesday 6 July, 18:30 - 21:00**

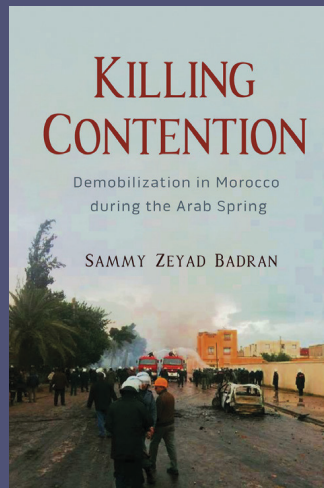
The documentary “Four Women of Egypt” (original French title “Quatre femmes d’Égypte”) was directed by Tahani Rached in 1997. The film is set in Egypt and revolves around four political activists, Safinaz Kazem, Shahenda Maklad, Wedad Mitry, and Amina Rachid, who have opposing religious, social, and political views. The film was highly acclaimed and won several awards.

After the film screening, there will be a public conversation and Q&A with the director Tahani Rached, two participants in the film (Prof. Reem Saad of AUC; activist and journalist Nawara Negm) and Islam Melba, an Egyptian director and film critic. The discussion will focus upon women rights, feminism, sociopolitical transformation and polarization in Egypt and MENA region during the last three decades. The panel participants will join us online. This conversation will be chaired and moderated by Dr Ahmed Abozaid, the film screening organiser with assistance from Davis Blakley and Centine Johansson, International Relations undergraduate students at the University of St Andrews.

## **Appropriation, Resistance and the Idea of the Moroccan Centre in the Medieval Maghribi Imaginary**

The history of North Africa west of the Nile Valley, like that of many regions, has been marked by numerous phases of imperial and colonial control which have shaped its history and historiography with successive empires sometimes celebrated for cultural and civilisational achievement and sometimes castigated for the oppression of an indigenous population, repeatedly deprived of linguistic, cultural and political autonomy. These imperial powers include the Phoenicians, the Romans, the Vandals, the Byzantines, the Arabs and the French. The naming and mapping of the Mediterranean littoral of the African continent and the mountains beyond had adapted and changed over time to express the perceptions of these different powers from Roman Africa to Arab Ifrīqiya and the Maghrib, to the modern Maghreb, shaped by its largely French colonial past. Although the conference theme relates primarily to the modern post-colonial experience, I shall consider the response of the indigenous population of northwest Africa, the Imazighen or Berbers, to their incorporation into the Arab-Islamic world and their gradual carving out of an independent role within it that adopted, adapted and challenged Arab-Islamic discourses in various ways. This process culminated with the twelfth-thirteenth century Almohad empire whose rulers claimed a centrality for their language, culture and capital city which is only now being fully appreciated by scholars of the wider Islamic world, perhaps due to the collapse of the Almohad empire and its cultural programme. Furthermore, in some parts of the Islamic West, the Almohads themselves were a conquering imperial power and faced contestation from other groups. Through this complicated case study from nearly a millennium ago, I hope to provide perspectives that may have relevance for the ambiguous and complex range of modern and contemporary responses to coloniality.

**Biography:** Amira K. Bennison is Professor in the History and Culture of the Maghrib at the University of Cambridge and a fellow of Magdalene College. Her teaching and research interests include the medieval Islamic West (Islamic Iberia and Morocco), Maghribi modes of legitimation and cultures of power, and 18th-19th century Muslim religio-political discourse and engagement with modernity. Her publications include *The Almoravid and Almohad Empires* (Edinburgh, 2016), *The Articulation of Power in Medieval Iberia and the Maghrib* (Oxford, 2014); *The Great Caliphs: the Golden Age of the 'Abbasid Empire*, (London, 2009); *Cities in the Premodern Islamic World: the urban impact of religion, state and society*, edited with Alison L. Gascoigne, (London, 2007); *Jihad and its Interpretations in Pre-Colonial Morocco*, (London, 2002), as well as numerous articles. She is currently working on a monograph about legitimation in the Maghrib over the *longue durée*, a general history of culture on the two sides of the Strait of Gibraltar, and a history of Muslim Iberia. Amira has led cultural tours to many parts of the Middle East and North Africa and she contributes regularly to television programmes on Islamic history. She is also a frequent guest on BBC Radio 4's 'In Our Time'.

## **Beyond Orders and Borders: The Refiguration of the Urban Spaces of the Middle East**

*Chaired by Dr Malaka Shwaikh, University of St Andrews*

The study of the Middle East has often started with history and geography, then moved to addressing issues of society, economy and politics. This presentation will attempt to address the urban question, and to highlight how the refiguration of cities is one of the most important dimensions to understand the sweeping changes in the region. The case of Egypt will be highlighted as an example of transforming the urban texture, and changing the balance of power in society through urban segregation. The pattern that is emerging is urban nodality and polycentrism. This will have an impact on governance and security. The regional and strategic consequences will be also explored.

**Biography:** Heba Raouf Ezzat is an assistant professor of political science at the Institute of Alliance of Civilizations at Ibn Haldun University in Istanbul, Turkey. She also teaches at the political science as well as the sociology department at IHU. For almost 30 years she taught political theory at Cairo University. She was also an adjunct professor at the American University in Cairo (2006-2013). She spent two years (2014-2015) at the unit for civil society and human security at London School of Economics (LSE) as a visiting fellow before moving to Istanbul 2016, where she is currently based. Her academic writings as well as teaching cover a wide range of topics that include classic and modern Western political thought, Islamic political theory, women and politics, global civil society, urban politics, cities and citizenships, and Middle East politics.

Besides her teaching and writings, she co-established a Diploma for Public Policy and Child Rights in 2010 that was a project funded by the European Commission and coordinated between 4 Arab Universities and 4 European Universities. For that effort she was awarded the Prize for Outstanding Support of German-Egyptian Collaboration in Science and Innovation.

Since 2015 she supervised and introduced the full translation of the Liquid Modernity series of Zygmunt Bauman into Arabic. She also translated Ziauddin Sardar's book on Mecca: The Holy City to Arabic. Her latest work is a research paper in the "Project on the future of human rights in the Arab world" titled: "The Human rights movement and the Islamist: The Paths of Convergence and Divergence" with the Arab Reform Initiative/Paris, and a forthcoming chapter titled "Re-imagining Egypt: The State of War" in a book on *Contemporary thought in the Middle East* (Routledge 2021). Her current research is on the reconfigurations of space in the Egyptian urban planning and urban politics, and the recent rise of Egyptian Ultranationalism.

# PLENARY KEYNOTE 3

**Professor Raymond Hinnebusch (University of St Andrews)**

**From Proxy War to Sanctions War: The Later Phases of the Syrian Conflict**

*Chaired by Dr Jasmine Gani, University of St Andrews*

Syria's conflict has metamorphized into a hybrid: a partially frozen proxy war over territory combined with a battle over sanctions and reconstruction. This paper will explore three aspects of this contest. The paper will look at the stalemated proxy war; the effort of the regime to use reconstruction to consolidate its power and marginalize opposition and the US effort to obstruct this. Syria is also a test case of the emerging global (dis) order: whether the US can use its dominance of the world financial system to sustain its world hegemony or whether its reinvention as a "sanctions hegemon" is the last episode in the transition to a multipolar world.

**Biography:** Raymond Hinnebusch is professor of International relations and Middle East politics and Director of the Centre for Syrian Studies at the University of St. Andrews. His works include *Egypt Politics under Sadat* (Cambridge 1980) *Authoritarian Power and State Formation in Ba'athist Syria* (Westview 1990) *Syria: Revolution from above* (Routledge: 2001); and *International Politics of the Middle East* (Manchester University Press 2003, 2015). 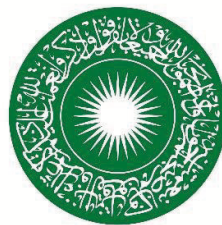
